**ATN HOLDINGS, INC. (ATNH) AND METRO PACIFIC TOLLWAYS CORPORATION (MPTC) EXECUTES MEMORANDUM OF UNDERSTANDING TO VARIOUS GOVERNMENT BUILD BUILD BUILD PROJECT.**

A Ceremonial Signing was held last night between ATN Holdings, Inc. and Metro Pacific Tollways Corporation at Edsa Shangrila, Mandaluyong City.

Under the Memorandum of Understanding, both Parties affirmed their continuing commitment of huge corporate resources and materials supply chain and construction capability to the Build Build Build Program of the Government. The MOU calls for the ATN supply of rock aggregates to five MPTC projects. MPTC is a major infrastructure player in the tollway projects of the Build Build Build program, while ATN Holdings, Inc. supports the Build Build Build Program through the “priority supply” of 250,000 cubic meters of rock aggregates to MPTC. *(picture attached showing existing 500,000 cu.m. of aggregate stockpile of ATNH)*



MPTC Group has enumerated several ongoing and new projects namely the (1) Harbour Link Project, (2) Cavite Laguna Expressway, (3) LRT-1 Cavite Extension, (4) NLEX-SLEX Connector Road Project, and (5) NLEX Expansion Project, which would require ATN support for the steady supply of rock aggregates.


ATN Group has presented its existing operation of a 500 ton/ hours fully engineered Crushing Plant and its future expansion projects including (1) a new 800 ton/ hour crushing plant, (2) Pre-cast Housing Plant with CMEC and Broad Homes, and (3) several Batching Plants.
